<ul style="list-style-type: none"> <li>• 21 years or over</li> <li>• security practitioner by profession, or has strong interest in the Objects of the Company</li> <li>• joining fee payable - amount dependent on age</li> <li>• preparatory stage to admission to Freedom of the Company</li> </ul>	<ul style="list-style-type: none"> <li>• Member for at least 12 months</li> <li>• Freedom fine payable - amount dependent on age</li> <li>• has attended at least 2 Company events and a New Member Briefing</li> </ul>	<ul style="list-style-type: none"> <li>• must be Freeman of the City of London</li> <li>• must have been a Freeman of the Company for 2 years</li> <li>• conduct as Freeman has been acceptable</li> <li>• must be an active member of the Company</li> <li>• Livery fine payable</li> <li>• must have no outstanding debts with the Company</li> </ul>	<ul style="list-style-type: none"> <li>• appointed by Committee Chairman</li> <li>• regular attendance expected</li> <li>• should be Liverymen, but may be Freeman who intends to seek Livery</li> <li>• qualifying criteria for election to Court</li> </ul>	<ul style="list-style-type: none"> <li>• elected by ballot of Liverymen and Freemen of the Company or, exceptionally, by the Court</li> <li>• must have been a Committee member for 2 years</li> <li>• fine payable on election</li> <li>• must seek re-election every 4 years</li> <li>• may not serve more than 12 consecutive years</li> </ul>	<ul style="list-style-type: none"> <li>• elected by the Court from Court Assistants</li> <li>• in office for a year</li> <li>• ex-officio member of Standing Committees</li> </ul>	<ul style="list-style-type: none"> <li>• elected by the Court</li> <li>• next step from Junior Warden</li> <li>• in office for a year</li> <li>• ex-officio member of Standing Committees</li> </ul>	<ul style="list-style-type: none"> <li>• elected by the Court</li> <li>• next step from Middle Warden</li> <li>• in office for a year</li> <li>• ex-officio member of Standing Committees</li> </ul>	<ul style="list-style-type: none"> <li>• elected by the Court</li> <li>• next step from Senior Warden</li> <li>• in office for a year</li> <li>• Chairman of the Court</li> <li>• ex-officio member of Standing Committee</li> <li>• at the end of the year as Master becomes Immediate Past Master (IPM) acts as deputy to the Master</li> <li>• remains on Court as a Past Master for the four years following their year as Master</li> </ul>
